4. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours, **on 12-02-2021 at Rajpur Rural Municipality**. There will not be obstacles to open the bid, if they will not present. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by Bid Security amounting in the table below which shall be valid for 120 days from the date of Bid opening.
5. If bidder wishes to submit bid security in the form of cash, the cash should be deposited in **Rajpur Rural Municipality, Dang, Account no. 51CA051000452401 at NIC-ASIA Bank Ltd. Rajpur Branch** and should submit scanned copy of original receipt of the deposited amount along with the bid.
6. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
